

WDA 2011 GENERAL COSTUME INFORMATION & PERFORMANCE GUIDELINES

Individual routine Costume Order Forms are available online.

WDA Company Make-up: Red Lips, Medium Blue Eye Shadow, Dark Pink Cheeks, Brown Accent Eye Shadow. Must be same color palette- Visit our website: <http://www.worlddancenarts.com/make-up.html>

All Company Tights: All routines require company tights purchased from WDA under your costume. Same color and brand: **Light Suntan**, unless otherwise specified. If you are in more than one routine you may use the same tights for all routines, but you are encouraged to order extra pairs in case your first pair becomes damaged or lost.

Extras for Your Performance Dance Bag: Extra Hair-matching Bobby Pins (always double cross bobby pins on all hair pieces), Hair-matching Hair Nets, Hair Spray, Hair-matching Hair Ties. Healthy snacks and water.

Costume Tips: Always Hand Wash Costumes and Drip Dry! (never machine wash or dry-clean). Bring extra safety pins. All COSTUMES ARE TO BE HUNG-UP AND KEPT IN A GARMENT BAG, WITH YOUR NAME WRITTEN ON EVERYTHING! Please no colored nail polish, clear only. No rings or other personal jewelry. Please do not wear undergarments under your costume, tights only.

Performance Eligibility:

- If registered before December 1st, 2010 you are eligible for the 2011 Performance season, AND competition readiness will be decided by instructor. *Only chosen routines will be attending competitions.
- If registered before February 1st, 2011 you are eligible for any scheduled 2011 Family Performances (based on costume availability).
- If registered after February 1st, 2011 you are eligible to participate in the Poway Days Parade in September 2011 and will join us for the 2012 Performance Season.

2011 Competition Date:

- Showstopper Competition in Anaheim: May 27th-30th

Due Dates For all Competition Fees- February 1st, 2011

Estimated Competition Fees(per competition):\$35-\$38 For Group Routines, \$35-\$55 For Duets and Trios, \$90 For Solos

Dancers that commit to Competition are required to be registered in a ballet class, have full attendance in the 4 classes before competition, and attend the Mandatory Rehearsal Dates: May 15th & 22nd. Times TBA.
Reminder- competition readiness is decided by instructor.

2011 Family Performance Dates:

- San Diego County Fair- End of June-Early July. TBA
- Poway Days Parade and Community Performance- Mid September
- Local Community Performance opportunities as they arise- TBA
- Dancin' At Sea Cruise- November 18th- 21st
